Good afternoon Mr. Allen,

Thank you for your response. I have some follow up concerns and points I want to urgently stress so we are all on the same page:

- ICE requests that **all** PODs be offered saturation testing as soon as possible using swap specimens (not ABBOT testing due to time constraints, procurement of enough testing supplies and expedited results GEO has received using the nasal swab).
- Designate a POD for positive cases
- Per GEOs recommendation, increase security inside PODs to address potential classification issues
- Ensure detainees are moved out of intake to appropriate housing.
- Engage DSM Movafagian for detention standards questions and recommendations
- Cohort detainees to appropriate PODs based on GEOs cohort plan
- Engage IHSC Obasi for medical issues

I realize we are all under tight constraints, but due to the health and welfare of our detainees we urge GEO to implement testing and cohorting today. I appreciate everyone's help dealing with this emergent issue.

- Dorm C should be offered testing before cohorting the detainees with dorm B detainees.
